## NCR begins drive against drug-n-rob gangs in zone

**ALLAHABAD:** The North Central Railway (NCR) on Tuesday launched a two-month drive against drug-n-rob gangs in the zone.

Under the campaign, NCR officials will make rail passengers aware of how to recognise and keep distance from members of such gangs and inform railway protection force (RPF) and the government railway police (GRP) personnel about them immediately, said public relations officer, NCR, Amit Malaviya.

"Announcement regarding purchasing edibles from only authorised vendors and not from strangers is also being made at stations to raise awareness among people," he added.

Malaviya said instructions had also been issued to travel ticket examiners and ticket collectors across the zone to raise awareness about drug-n-rob gangs while checking rail tickets.

He said rail passengers at the stations of Agra and Jhansi divisions were informed about such gangs which rob innocent passengers by offering them edibles laced with some high-intensity intoxicants.
